Archives & History

General Conference

General Conference meets every four years. In 2008, General Conference is being held in Ft. Worth, Texas from April 23rd to May 2nd. Here, up to 1,000 delegates, half clergy and half lay persons, from across the United States and around the globe will come together and revise the Book of Discipline. The Book of Discipline is the "record of laws" which dictates church regulations, membership, ordination, administration, property and judicial procedures.

Without the critical funding of the General Administration Fund, delegates from across the connection could not come together and make forward changes to the Book of Discipline and outline the future of the church for the next four years. Judicial Council

The Judicial Council is the highest judicial body or “court” of The United Methodist Church. It is comprised of nine members. The majority alternates every eight years between a majority of clergy and a majority of lay persons. Members of the Judicial Council are elected by the General Conference.

The funding for the Judicial Council is made possible by the General Administration Fund. The General Administration Fund provides financial support for ministries that are administrative in nature, rather than program in nature. This vital support makes possible the Judicial Council meetings and supports their ministry as our high court.
